Subject: Continuation of Recognition of MBBS degree (150 seats) granted by Madhya Pradesh Medical Science University, Jabalpur in respect of the students being trained at Chirayu Medical College and Hospital, Bhopal, Madhya Pradesh.

Sir,

I am directed to say that your college was assessed by the Assessors appointed by MARB to conduct virtual assessment on the conduct of examination on 7th June, 2022. The physical assessment report is not available with the UGMEB. However, as per the decision taken in the Commission in its meeting held on 11.04.2023, in case infrastructural assessment as well as examination assessment have been carried out, the application for Continuation of Recognition should be processed as per the regulation norms. In case only one assessment has been carried out, Continuation of Recognition is to be processed **for only one year** henceforth.

2. Accordingly your college was considered for grant of Continuation of Recognition (only for one year) of MBBS degree (150 seats) awarded by Madhya Pradesh Medical Science University, Jabalpur. While evaluating the assessment report alongwith the AEBAS and HMIS data including CCTV, following was observed:

(A) Deficiency in Faculty and Resident as observed on AEBAS record:

Total working days assessed: 07

The faculty and Senior Resident Doctor deficiency is calculated on the basis of attendance of registered persons by the college on AEBAS records. The attendance of these faculty is ranging from zero to less than 50% of the total working days.

Out of 356 persons registered, 193 have zero attendance and 19 have less than 50% attendance.

(B) Other deficiency:

HMIS showed that cameras are not functioning at least for the last two months, when checked on 11th July, 2023.

3. After careful consideration, it has been decided by the Under Graduate Medical Education Board (UGMEB) that Chirayu Medical College and Hospital, Bhopal, Madhya Pradesh is granted one year recognition to the MBBS qualification, with directions to college authorities to rectify the shortcomings/deficiencies mentioned above and fulfill all the requirements as per prevalent rules & regulations.

4. Accordingly, the approval of the competent authority in UGMEB is hereby conveyed for grant of **CONTINUATION OF RECOGNITION FOR ONE YEAR** for MBBS degree for 150 students, awarded by Madhya Pradesh Medical Science University, Jabalpur in respect of the students being trained at Chirayu Medical College and Hospital, Bhopal, Madhya Pradesh.

5. You are also directed to rectify the shortcomings/deficiencies mentioned above and advised to apply afresh to UGMEB in 2024 for Continuation of Recognition, at least six (6) months prior to the final examination of MBBS Part-II (Practical) alongwith the requisite fee i.e. Rs. 3.54 lakhs only.
